

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.serenityfarmgypsyhorses.info, and Serenity Farm Gypsy Horses LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Serenity Farm Gypsy Horses LLC include www.serenityfarmgypsyhorses.info and Serenity Farm Gypsy Horses. The Serenity Farm Gypsy Horses website is a Horse Breeding and Riding Center site. By using the Serenity Farm Gypsy Horses website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Serenity Farm Gypsy Horses may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Serenity Farm Gypsy Horses's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Serenity Farm Gypsy Horses may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Serenity Farm Gypsy Horses's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

Sharing Information with Third Parties

Serenity Farm Gypsy Horses does not sell, rent or lease its customer lists to third parties.

In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Right to Deletion
